An Ordinance to amend criminal penalty provisions set forth in the Maple Grove Township Zoning Ordinance Section 704 (2) (D), the Maple Grove Township Dog Control Ordinance No. 150, and the Maple Grove Township Anti-Noise Ordinance.

THE TOWNSHIP ORDAINS:

SECTION 1:

This ordinance shall be known and cited as the Maple Grove Township Sanctions for Ordinance Violations Ordinance.

SECTION 2:

The Maple Grove Township Zoning Ordinance Section 704 (2) (D), the Maple Grove Township Dog Control Ordinance No 150, and the Maple Grove Township Anti-Noise Ordinance are amended to read as follows:

Any person or other entity who violates any of the provisions of this Ordinance is responsible for a municipal civil infraction as defined by Michigan law and subject to a civil fine determined in accordance with the following schedule:

1 st VIOLATION

*JUDGE SETS FINES

Additionally, the violator shall pay costs, which may include all direct or indirect expenses to which the Township has been put in connection with the violation. In no case, however, shall costs be less than \$9.00 or more than \$500.00 be ordered. A violator of this Ordinance shall also be subject to such additional sanctions, remedies, and judicial orders as are authorized under Michigan law. Each day a violation of this Ordinance continues to exist constitutes a separate violation.

SECTION 3:

All ordinances or parts of ordinances in conflict with this Ordinance are repealed.

SECTION 4:

This Ordinance shall take effect thirty (30) days after publication as required by law following adoption by the Township Board.
