Minutes of a regular meeting of the Township Trustees of Maple Grove Township, Saginaw County, State of Michigan, held on the 18th day of January, 2021 at 7:00 p.m., prevailing Eastern Time.

The following preamble and resolution were offered by Treasurer Yaros and supported by Supervisor Krupp.

WHEREAS, on January 18, 2021 the Township Board received a request from The Estate of Sharon Gross, Eric Gross, Trustee for approval to have a certain parcel released from Agreement number: 73-9843-123122 which was executed in accordance with the provisions of PA 116 of 1974, commonly known as the Farmland and Open Space Preservation Act; and

WHEREAS, the township board has reviewed this request and determined that the parcel is to be released for someone who is essential to the farm operation; and

WHEREAS, the parcel proposed for release from the agreement is 5.00 acres in size; and

WHEREAS, the township board finds that that request for release of the particular parcel is acceptable;

NOW THEREFORE BE IT RESOLVED BY THE MAPLE GROVE TOWNSHIP BOARD AS FOLLOWS:

That the township board hereby approves the request to release the following described piece of property from the PA 116 agreement:

A parcel of land in the South 1/2 of the Southeast 3/4 of Section 17, T9N R4E Maple Grove Township, Saginaw County, Michigan described as follows: Beginning at a point on the South line of said Section which is 942.88 feet, 5.89—52' -49"W. of the Southeast Corner of said Section, thence continuing S.89- 52'-49"W., on said South Section line, 413.07 feet; thence N.01-21'-44"W., parallel with the East 1/8 line of said Section, 527.40 feet; thence N.89-52'-49"E., parallel with said South Section line, 413.07 feet; thence S.01-21'-44"E., parallel with said East 1/8 line, 527.40 feet to the point of beginning, containing 5.00 acres of land and subject to highway use per recorded easement to Michigan Department of Transportation recorded in Liber 607, Page 492, and also subject to any other easements of record.


(1) That the township board hereby certifies that the parcel is to be released for someone due to a death of the person named in the agreement.
