# RESOLUTION TO ADOPT ROAD IMPROVEMENT, REPAIR AND MAINTENANCE MILLAGE INCREASE PROPOSAL

Minutes of a regular meeting of the Township Trustees of Maple Grove Township, Saginaw County, State of Michigan, held on the 16th day of May, 2022 at 7:00 p.m., prevailing Eastern Time.

PRESENT: Supervisor Krupp, Treasurer Yaros, Clerk Yaros, Trustee Peterman and Trustee Wendling.

### ABENSET: None.

The following preamble and resolution were offered by Supervisor Krupp and supported by Trustee Peterman.

WHEREAS, townships may impose and levy *ad valorem* property taxes to finance lawful public improvements as authorized by the Michigan Constitution and other laws. Specifically, townships may provide funds to improve, repair, and maintain roads within the Township as authorized by Public Act 51 of 1951, MCL 247.651 *et seq.*, among other authorities; and

WHEREAS, the Township Board of Maple Grove Township wishes to levy a new millage of 2.00 mills for six (6) years, 2023 through 2028 inclusive, to improve, repair, and maintain roads within the Township as authorized under Michigan law.

#### NOW, THEREFORE, BE IT RESOLVED

1. The Township Board of Maple Grove Township, Saginaw County, Michigan, approves the following millage increase proposal language and directs the Clerk to submit it to be placed on the November 8, 2022 election ballot:

# MAPLE GROVE TOWNSHIP MILLAGE INCREASE PROPOSAL ROAD IMPROVEMENT, REPAIR AND MAINTENANCE

Shall Maple Grove Township impose an increase of up to 2.0 mills (\$2.00 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Sec.6 of the Michigan Constitution, subject to the required millage rollbacks, and levy it for six (6) years, 2023 through 2028 inclusive, to improve, repair and maintain roads within Maple Grove Township, raising an estimated \$187,300 in 2023?

Shall Maple Grove Township impose an increase of up to 2.0 mills (\$2.00 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Sec.6 of the Michigan Constitution, subject to the required millage rollbacks, and levy it for six (6) years, 2023 through 2028 inclusive, to improve, repair and maintain roads within Maple Grove Township, raising an estimated \$187,300 in 2023?
